Entering Zambia Legally: A 2025 Guide to Visa Categories, Entry Types, and Immigration Expectations

For many foreigners planning to enter Zambia, understanding the visa process is often one of the most confusing—and yet most critical—parts of preparing for their journey. Whether you're an immigrant yourself, a legal practitioner assisting a client, or a student hoping to enter the field of immigration law, knowing how Zambia's visa system works is not just useful; it's essential.

In Zambia, the immigration framework is structured in a very specific way. Unlike in some countries where the terms *visa* and *permit* are used interchangeably, Zambian immigration law draws a clear line between the two. A **visa** is simply the authority to enter the country. A **permit**, on the other hand, is the authority to stay or remain in Zambia. These are distinct legal concepts, and understanding them is the foundation upon which all other immigration compliance rests.

# Understanding Entry Categories

To make this practical, let's start with the entry process itself. Foreigners entering Zambia fall into one of two broad visa categories: the **Ordinary (or Tourist) Visa** and the **Business Visa**.  $\square$ 

The difference lies in the purpose of entry.

If a person is coming purely to visit family or friends, or for sightseeing or other non-official reasons, then they are considered an ordinary or tourist visitor. These individuals are not permitted to engage in any form of business or official activity while in the country, whether paid or unpaid.

If, however, the foreign national is entering Zambia for any purpose that is official in nature—such as meetings, conferences, investment-related visits, research, study, or work—then they fall within the **business visa** category.

This distinction is important because it not only governs how long one can stay, but it also affects what permits (if any) they may later be eligible for.

# What Happens at the Border

At the point of entry—be it an airport or land border—an immigration officer will examine the entrant and issue an endorsement in their passport. It is at this moment that the foreign national must declare their **true purpose of entry** or produce their visa approval letter or visa where such entrant was issued with the visa prior to

travel.

If, for example, someone is visiting as an ordinary visitor/tourist, the stamp in their passport will typically read something like V/30D until [date], meaning "Visitor for 30 days until [expiry date]". That 30-day period can then be extended up to a maximum of 90 within an immigration year.

It's important to note here that an immigration year is not the same as a calendar year—it runs for 12 months from the date of entry. So, if Mr. John Smith enters Zambia on 18th June 2025, his immigration year will end on 19th June 2026, and he can use his 90 days at any time during that period.

A business visitor, however, is only allowed a **total of 30 days per immigration year**, and this time is **not extendable**. Once the 30 days are exhausted, they must leave Zambia or apply for a relevant immigration permit.

# Common Pitfall: Misrepresentation

This brings us to a common challenge. Some individuals attempt to enter Zambia under the guise of being ordinary visitors, simply to benefit from the longer 90-day allowance—even though their true intent is to work, consult, or conduct business.

Unfortunately, this creates problems down the line. When such individuals later apply for a work or business related permit, they are required to submit a copy of their **last entry endorsement**. If that endorsement shows they entered as a visitor rather than for business, their permit application is usually **rejected** due to misrepresentation of their initial purpose. X

It is a mistake that can delay plans, damage immigration records, and cost more in the long run.

### Other Visa Options Worth Knowing

Beyond the main visa categories, there are also a few what we may loosely call "sub-visas." These include:

- The **Transit Visa** for foreigners transiting through Zambia via land transport. Usually valid for 7 days.
- The Day-Tripper Visa for same-day visits (maximum of 24 hours), with exit required through the same port of entry.
- The KAZA UniVisa a tourism visa allowing travel between Zambia and Zimbabwe on a single visa.

While these visas serve specific functions, they are usually aligned with either the business or tourist categories, depending on the purpose of entry.

# Single vs. Multiple Entry

Zambia also categorizes its visas by frequency of entry:

- Single-entry enter Zambia once
- **Double-entry** enter, exit, and re-enter once
- Multiple-entry enter and exit as needed during the visa's validity

For those planning frequent visits—whether for business, family, or both—a multiple-entry visa is often more economical and convenient.

### Which Entry Regime Applies to You?

Zambia classifies foreign nationals into three general groups when it comes to visa requirements:

- I. Visa-exempt countries/Visa Free no visa needed
- 2. **Visa-on-arrival nationals** visa can be obtained and paid for at the port of entry
- 3. **Pre-visa nationals** must apply for and receive approval and printable visa before traveling to Zambia

Understanding which category applies to you can save time and ensure a smoother arrival experience.

### Staying Longer: Permits and Compliance

Should a foreign national wish to remain in Zambia beyond their visa duration, they must apply for an appropriate immigration permit.

The Department of Immigration issues different permits depending on the stated purpose of stay—whether it's to study, to work (short- or long-term), to reside as a spouse of a Zambian citizen or resident, to engage in cross-border trade, or to invest in Zambia.

Importantly, the permit one is eligible for often depends on the original purpose of entry as declared at the port or at visa application stage—this directly informs their eligibility for continued stay.

By understanding Zambia's visa categories and entry protocols, foreign nationals can make informed decisions, avoid unnecessary obstacles, and ensure a smooth and

legally compliant experience when entering the country.
